GENERAL CONDITIONS OF SALE - HARDWOOD TIMBER SALE 2024

Please note that as from 1 April 2019 Forestry England is the forestry business agency of the Forestry Commission acting in exercise of the powers and duties contained in the Forestry Act 1967.

1. The sale of each Lot offered at this auction is subject to the printed conditions contained in this catalogue and each Lot sold will be subject to either a Forestry England Standard Contract or a Memorandum of Agreement and Standard Conditions of Sale, dependant on the Vendor of each Lot, specimens of which may be obtained from the Vendors and/or the Auctioneers and which will be available for scrutiny in the auction rooms. The contact name and address of the Vendor is given with the details of each Lot.
2. The Vendor reserves the right to make one bid for each Lot (the reserve price), which shall be delivered to the Auctioneer in a sealed envelope before the commencement of the sale.
3. The highest bidder shall be preferred (subject to the undisclosed reserve price) and shall be bound by these Conditions of Sale and shall initially sign a Forestry England Standard Contract or Memorandum of Agreement (dependant on the Vendor of any particular Lot) on the day of the sale. Confirmatory documents will be forwarded to the successful bidder as soon as possible thereafter.
4. The Vendor reserves the right to withdraw Lots or to alter the published order of sale of the Lots. If such changes are made they will be announced by the Auctioneer before the sale commences.
5. The sum by which each offer must exceed the immediately preceding offer shall be at the discretion of the Auctioneer.
6. All Lots will be offered for sale on either a lump sum basis, or a price per cubic metre, or price per tonne, and the auctioneer will invite bids as described on the relevant catalogue page.
7. All bids shall be exclusive of Value Added Tax, which shall be added to the purchase price of each Lot at the appropriate time.
8. At the conclusion of bidding for a Lot, the sealed reserve will be opened and if the last bid equals or exceeds the reserve price, the Lot will be knocked down. A contract is formed when a Lot is declared sold. If the reserve is not reached the Vendor may endeavour, at the conclusion of the Auction and in the sale room, to negotiate a sale with the highest bidder provided the latter gives intimation to this effect.
9. The Auctioneers, David James, shall be the judge of the sale with powers to determine all differences arising during the sale.
10. No Lot carries entitlement to the offer of continuity of supplies of timber outside the Terms and Conditions of the Contract.
11. The description of the trees in the Sale Catalogue is believed to be accurate but is not guaranteed. In all respects the Purchaser is held as satisfying himself as to the description of the sale Lots.
12. Date of commencement of Contracts will be stated in the Special Conditions described with each Lot.
13. Date of completion of Contracts will be stated in the Special Conditions described with each Lot.
14. Payment conditions are as stated in the Forestry England Standard Contract or Memorandum of agreement referred to in 1 above or as otherwise specified by the vendor. Your attention is drawn to the clause in the specimen Forestry England contracts, which describes the normal terms of trading with Forestry England. Application of these terms, which is at the sole discretion of the Vendor is subject to establishment of satisfactory credit worthiness.
15. Arrangements to inspect the timber should be made directly with the appropriate Forester or Agent, as indicated in the Catalogue. Purchasers will be deemed to have acquainted themselves

with arrangements for access and constraints, if any, in respect of each Lot, details of which are also available from the Forester or Agent.

16. Special Conditions of Sale referred to in each Lot are additional to the General or Standard Conditions of Sale. Purchasers are deemed to have acquainted themselves with these Special Conditions whether referred to in the Catalogue or not, details of which are available from the respective Forester or Agent.

17. Latecomers to the Sale will be deemed to have acquainted themselves with the Conditions of Sale and copies of this Catalogue, containing these Conditions, are available in the Saleroom for this purpose.

18. When working purchased lots, safety signs conforming to British Standard BS5378, which warn individuals of a hazard and/or prohibit entry, are to be provided by the Purchaser and maintained to the satisfaction of the Vendor.

19. All users of chainsaws on Vendors' property will be required to hold an appropriate and Certificate of Competence issued by the National Proficiency Tests Council (NPTC) or hold the equivalent modern award issued by LANTRA. Unit awards accredited by the National Council for Vocational Qualification (NCVQ) will be recognised as having a status equivalent to the NPTC Certificates. Self-employed chainsaw operators are responsible for ensuring they acquire the necessary certificates of competence. Timber merchants, management companies, etc., who employ chainsaw operators are responsible for ensuring that those operators are correctly certificated. All chainsaw operators will be required to produce evidence of certification and evidence of compliance with the Forest Industry Safety Accord (FISA) requirements for periodic refresher training (or evidence that any such training need has been registered with FISA).

20. 'Trainees' will be allowed to operate chainsaws on Forestry Commission land for the purpose of gaining post training consolidation, prior to formal NPTC Certification, if they possess a valid Record of Training and Achievement issued by FASTCO. For the purposes of this Condition, a valid Record of Training and Achievement, is one issued post November 1993, and which is still current.

21. The Purchaser will be responsible for ensuring all Young Workers (under 18 years) using chainsaws whether as trainees or qualified operators are supervised and managed in accordance with the Health and Safety Executive's Guidance Note INDG 317.

22. For all contracts, machine operators undertaking operations included within the scope of the Forest Machine Operator Certification Scheme are required to have successfully completed the relevant assessments. Trainee operators will be accepted subject to specific agreement but must be registered with the Scheme.

23. The movement of purchased timber must fully comply with all security and despatch arrangements required by the Vendor and follow the Road Haulage of Round Timber Code of Practice available from the Timber Transport Forum (www.timbertransportforum.org.uk)

24. All Forest England timber sold in this auction is covered by FSC and PEFC certification codes issued by the Soil Association. For private lots please check with the vendor.

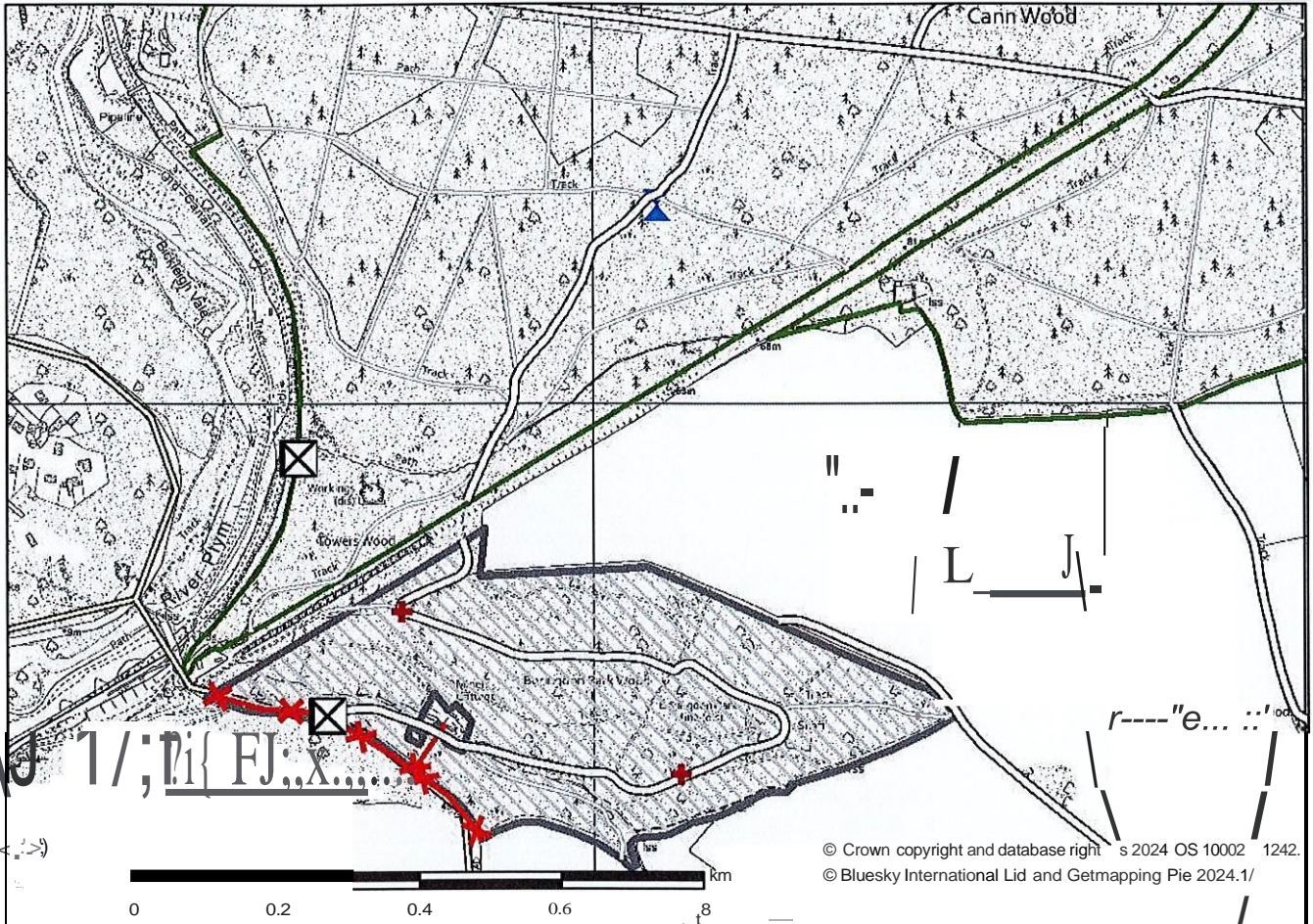

To Mark 50 Years of Live Timber Auctions
For the
Forestry Commission and Private Growers
Of
Hardwood and Conifer

The 37th Hardwood Auction marks the completion of 50 years of these sales, conducted basically by the same firm, from Rennie Taylor Miles & Escott to today, being David James.

The first Auction was of conifer entered from the three conservancies, West England, South East and South Wales, held in February 1974 at Westonbirt, offering 51 Lots. From then on the sale took place at different venues and a larger number of Lots – about 130 being the maximum. Then there were separate sales solely for England, Scotland and Wales until the early part of this century when live soft wood auctions were phased out and carried out on the web.

However, in 1987 this firm started Hardwood Timber Auctions with the help of the late Mr John Everard who guided us to formulate a catalogue for hardwood timber, some of which was based on the French auction system which John had attended. The first Hardwood Auction was held at The Speech House, Forest of Dean on 8 October 1987 in the Verderer's Court. Just over 6,000 cu.m. were on offer. The success of this auction was the foundation for the remaining 37 years, apart from one year as a result of the windblow in South England.

That then is a very brief history, probably over 120 auctions of sales by live auction during which there have been many firms and great individual characters attending. Although always in good spirit the essence of a live auction is that it epitomises competition and its openness is appreciated by the buyers.

It has been my privilege of attending every one of the auctions and conducted the sale of nearly all, with the first two auctions conducted by the late John Rennie and more recently by my colleagues Keith Spencer, Phil Jones and Olivia Hale. I hope they have as much enjoyment from these sales and meeting a wide cross section of foresters as I have been lucky to experience.

Just to mark the different sales, set out below are copies of the front pages of the first auctions. The first solely Welsh Auction and the South Scotland Auction, together with the first Hardwood Auction in the Forest of Dean.
